

Tuition and Fees¹

Associate of Applied Science Degree (AAS) Programs:

Taylor Business Institute's associate degree programs are approved for degree-granting by the Illinois Board of Higher Education (IBHE).

Tuition for Taylor Business Institute's degree programs is charged on cost per credit hour basis. Taylor Business Institute's cost per credit hour is \$295.00 for U.S. Residents and \$216.67 for Non-U.S. Residents. For students attending full-time (12 credits) the tuition cost for the quarter is \$3,540.00 for US Residents and \$2,600.00 for Non-US Residents. Students attending more than twelve credit hours will be charged for the hours above 12 credits at the cost per credit hour rate. Students, who for any reason, must repeat classes to complete their program will be charged the current tuition rates for classes repeated.
